WHEREAS, during development of the FFY 2017 – 2021 TIP the Elmira-Chemung Transportation Council solicited projects from all municipalities in Chemung County with Federal Aid eligible highways, including Chemung County, and

WHEREAS, a project rating subcommittee and rating criteria were established to evaluate projects received in the solicitation, and

WHEREAS, three projects were prioritized under the project selection process for inclusion in the ECTC FFY 2017-2021 TIP, including the Coleman Avenue Project, and

WHEREAS, under ECTC Ballot 15-P6 two of the three projects were added to the TIP, and

WHEREAS, the Coleman Avenue project was selected as a potential TIP project but not added to the TIP at that time so that appropriately detailed cost, scope and schedule information could be developed, and

WHEREAS, the cost, scope and schedule has been defined to the extent that the project can be added to the TIP, and

WHEREAS, the funding for this project will be offset with block PINs 6TEC05, 6TEC08, and \$94,000 of additional Federal aid from the NYSDOT, and

WHEREAS, any project within the MPO Planning area utilizing Federal funding must be included in the TIP with the appropriate costs and schedules,


